Terms and Conditions (Games of Skill)

- 1 By entering this promotion, you accept these Terms and Conditions.
- 2 Instructions and information on how to enter this promotion form part of these Terms and Conditions.
- 3 The promoter is UQ Sport (ABN 25 135 537 183) of St Lucia, Queensland, 4067 ("**Promoter**").

Eligible entrants

- 4 To be eligible to enter this promotion, you must:
 - (a) be a current University of Queensland student with a valid student number.

How to enter

- 5 Entry will be open from [09:00] AEST on [20/08/2025] and closes at [09:00] AEST on [11/09/2025] if not already full ("**Entry Period**"). Entries received outside of the Entry Period will not be accepted.
- 6 To enter, you must, during the Entry Period:
 - (a) Visit <https://uqsport.com.au/uqslam/> and fully complete the online entry form, including full name, address, email address, telephone number, and UQ Student Number;
- 7 You will receive one entry into the promotion by performing the activities listed in clause 6. You may not enter the promotion more than once.
- 8 All entries become the property of the Promoter.

Judging

- 9 This promotion is a game of skill. Chance plays no part in determining the winners.
- 10 All valid entries will be judged according to the performance of their team in the tournament. The team that scores more points in the grand final will be awarded 1st place. The losing grand final team will be awarded 2nd place. The winner of a 3rd vs 4th playoff will be awarded 3rd place.
- 11 Judging will take place at 20:00 AEST on [19/09/2025] at the UQ Sport Multi-use Courts. Entries will be judged by UQ Sport's Competitions staff and referees.
- 12 The Promoter may decline to accept any entry which, in its reasonable opinion, does not comply with these Terms and Conditions.
- 13 The Promoter's decision in relation to any aspect of the promotion is final and the Promoter will not enter into any correspondence regarding the result of the promotion.

Prize and notification of winners

- 14 The winning teams of the men's and women's competition will receive the following
 - (a) 1st place - Eftpos gift cards to the value of \$500 to share with up to 5 team members

- (b) 2nd place - Eftpos gift cards to the value of \$300 to share with up to 5 team members
 - (c) 3rd place - Eftpos gift cards to the value of \$200 to share with up to 5 team members
- 15 Prizes are not transferable and cannot be taken as cash.
- 16 The winner of the men's and women's competition will be notified on the day of the competition after the grand final is played on Friday 19 September after 21:00AEST. Results of the prize draw will also be published on the UQ Life Facebook page: <https://www.facebook.com/uqlife/> and UQ Sport Facebook page: <https://www.facebook.com/uqsport/> on or after Friday 19 September.
- 17 To claim the prize, the winning team members must provide their email and phone number on the night of the competition, or reply by email with their phone number to organise to pick up their prize. The prize must be claimed within two weeks after the event. The prize must be collected by Friday 3 October by 17:00AEST from Building 41 at St Lucia campus.
- 18 If the Promoter is unable to contact the winner by 17.00AEST on Friday 3 October that winner will forfeit the prize.
- 19 If any prize becomes unavailable for any reason, the Promoter may substitute a prize of equal or greater value.
- 20 The Promoter accepts no responsibility for any tax implications that may arise for any prize.

Intellectual property

- 21 You confirm and promise that your entry is original and does not infringe the intellectual property rights of any third party. You agree that the Promoter has an unrestricted, irrevocable, transferable, right and licence to use and modify your entry including for promotional purposes without the payment of any further fee or compensation or further reference to you, and that the Promoter can authorise other people to do any of these things.
